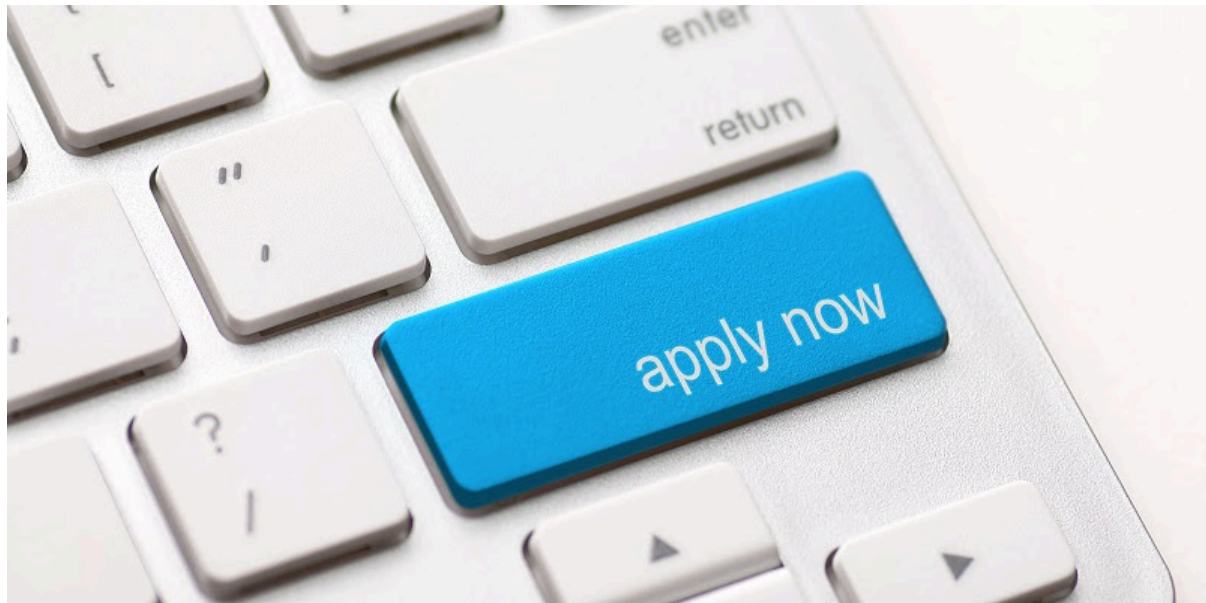

Member applications should be received by BANT by the **7th April 2025** and successful applications will be confirmed at the BANT AGM.

How to Apply

If you feel you have made a significant contribution to the profession and/or advanced the

practice of nutritional therapy, and would like to be a candidate for the category of Fellow Member, then please provide the following:

- [Completed Application Form](#) - which must be signed and dated
- Updated CV
- A timeline detailing the roles and positions you have held that demonstrate your contributions to the profession, support of nutritional therapy practice or BANT
- Provide a 300 word statement demonstrating how you meet the assessment criteria
- [References](#) from two members of BANT in support of your application

Applications are assessed by BANT Council in April and you will be informed in writing whether your application has been successful or not by the 1st of May 2025.

Applications need to be received by BANT by the 7th of April 2025 by email to generalmanager@bant.org.uk.

Applications received after this date, or any incomplete applications, will not be considered.
